2. Mrs Niaz may act as a solicitor, only as an employee and only where that employment has first been approved by the SRA
3. Mrs Niaz may not as a compliance officer for legal practice (COLP) or a compliance officer for finance and administration (COFA) for any authorised body.

In these conditions the terms are as defined in the SRA

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the



regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

## **Outcome details**

This outcome was reached by SRA decision.

### **Reasons/basis**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that, while in practice as a solicitor at Lewis Mitchell Solicitors:-

1. During the period between 18 January 2020 and 1 September 2023, she practised as a sole practitioner without authorisation.
2. During the period between 18 January 2020 and 1 September 2023 held client monies when she was not working in an authorised body.
3. During the period between June 2016 and 1 September 2023 failed to maintain proper accounting records in that she:
  - i. Failed to carry out reconciliations every 5 weeks
  - ii. Failed to complete Accountants' reports as required

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.

2. Mrs Niaz may not act as a compliance officer for legal practice (COLP) or a compliance officer for finance and administration (COFA) for any authorised body.
3. Mrs Niaz may not provide legal services as a freelance solicitor offering reserved or unreserved services on her own account under Regulation 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.

In these conditions the terms are as defined in the SRA Glossary.

**Reasons/basis**

The above interim conditions are made under rule 3.2 of the SRA Regulatory and Disciplinary Procedure Rules, which states that at any stage an authorised decision maker may, pending a final decision by the SRA or the Solicitors Disciplinary Tribunal, impose interim condition(s) on the practising certificate of a solicitor. We are satisfied that these

conditions are necessary in the public interest or for the protection of the public.
