Introduction

These rules set out what the SRA does with money it takes possession of following an intervention into a firm's and/or an individual's practice. We hold this money on trust for the people it belongs to. This type of trust is called a statutory trust. The people that the money belongs to are beneficiaries of the trust. We have produced <u>guidance on the way that we deal with this money [https://beta.sra.org.uk/sra/decision-making/]</u>.

Rule 1: Holding statutory trust monies

- 1. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall place all <u>statutory trust monies</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustmonies] in an identifiable <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount].
- 2. All interest earned on the funds held in any <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount] shall be paid into that account.

Rule 2: Identifying beneficial entitlements

2. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> will create a <u>reconciled list [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#reconciled-list]</u> or a <u>best list</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#best-list]</u> in respect of <u>statutory trust monies [https://beta.sra.org.uk/solicitors/standards-</u>



<u>regulations/glossary/#statutory-trust-monies]</u> held, using the information which it has available.

- 3. In creating a reconciled list [https://beta.sra.org.uk/solicitors/standardsregulations/glossary/#reconciled-list] or a best list [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#best-list], any sums of money which are identified within a statutory trust account [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount] as being payments on account of fees [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#fees] or unpaid disbursements [https://beta.sra.org.uk/solicitors/standards-<u>regulations/glossary/#disbursements]</u>, or which are equivalent to the <u>costs</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#costs] incurred in a matter to which the funds relate, will be treated as due to the client [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#client] rather than the intervened practitioner [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#intervened-<u>practitioner</u>], unless there is sufficient evidence of a bill or other written notification of costs [https://beta.sra.org.uk/solicitors/standardsregulations/glossary/#costs] having been sent to the client [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#client]_ 4. The SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]
- 4. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> will attempt to contact all <u>persons</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#person] identified as having a potential beneficial interest in the <u>statutory</u> <u>trust monies [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust-monies]</u> and invite them to submit a claim in accordance with rule 4.

Rule 3: Minimum level of funds

- 3. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may set a minimum level of funds to which a <u>beneficiary</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary]_may be entitled within a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount]_below which it will not attempt to identify or locate potential <u>beneficiaries [https://beta.sra.org.uk/solicitors/standards-</u> regulations/glossary/#beneficiary]_on the basis that, in the opinion of the <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, it would be unreasonable or disproportionate to do so.
- 4. The level in rule 3.1 applies to the sum identified as relating to a particular <u>beneficiary [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary]</u>, after the application of any pro-rata adjustment which may be made under rule 6.2 but without including any interest under rule 7.3.

Rule 4: Claimants to money

4. Unless the <u>SRA Ihttps://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA1</u> agrees otherwise, every <u>claimant</u> <u>Ihttps://beta.sra.org.uk/solicitors/standards-regulations/glossary/#claimant1</u> must submit to the <u>SRA Ihttps://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA1</u> a claim in the <u>prescribed</u> <u>Ihttps://beta.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed1</u> form accompanied by any documentation and other evidence as may be required by the <u>SRA Ihttps://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA1</u>, and which must include, if requested by the <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA1</u>, a statement of truth.

Rule 5: Verification of claims

5. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may verify the individual potential beneficial entitlements claimed under rule 4 by examining all available evidence.

Rule 6: Shortfall in statutory trust account

- 6. In cases where a shortfall is revealed between <u>statutory trust</u> <u>monies [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust-monies]</u> held, and the beneficial entitlements shown in a <u>reconciled list [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#reconciled-list]</u> or <u>best list</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#best-list]</u>, the <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may rectify the position, in whole or in part, by the use of other monies taken into its possession in consequence of the intervention to which that list relates.
- 7. Where, having applied additional funds under rule 6.1, a shortfall still exists on a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount], the <u>SRA [https://beta.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA] will decide on the method for calculating how



to distribute the funds that are available in the account to <u>beneficiaries [https://beta.sra.org.uk/solicitors/standards-</u>regulations/glossary/#beneficiary].

Rule 7: Distribution of beneficial entitlements

- 7. In a case where the accounting records of the <u>intervened</u> <u>practitioner [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#intervened-practitioner] are reconciled accounts [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#reconciled-accounts], payments to <u>beneficiaries</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary] will be made on the basis of the <u>reconciled list</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#reconciled-list].</u>
- 8. In a case where the accounting records of the <u>intervened</u> <u>practitioner [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#intervened-practitioner]</u> are not <u>reconciled accounts</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#reconciled-accounts]</u>, payments to <u>beneficiaries</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary]</u> will be made on the basis of the <u>best list</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#best-list]</u>.
- 9. Any interest which has accrued on a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount] under rule 1.2, will be distributed to <u>beneficiaries</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary] On a pro-rata basis in proportion to the payments made to them under rule 7.1 or 7.2.

Rule 8: Residual balances

- 8. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may use any funds which remain in a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust-account] following the distribution to <u>beneficiaries</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary] under rule 7 to reimburse any costs, charges, or other expenses, which it has incurred in establishing the beneficial entitlements to the <u>statutory trust monies [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust-regulations/glossary/#statutory-trust account</u>] and in distributing the monies accordingly.
- 9. If funds remain in a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust-<u>account</u>] after payment to <u>beneficiaries</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary]_and



the reimbursement of costs, charges and expenses in accordance with rule 8.1, the <u>SRA [https://beta.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> may transfer such remaining funds into the compensation fund held by the <u>SRA</u> [<u>https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> and any claim to such funds under these rules shall be extinguished.

Rule 9: Interim payments

9. The <u>SRA [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make an interim payment to a <u>beneficiary</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#beneficiary.] before the full distribution of funds in a <u>statutory trust account</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trustaccount] takes place provided that the <u>SRA</u> [https://beta.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] is satisfied that the payment can be made without prejudicing other claims to those funds.
